Sanction is hereby accorded to the advance drawal and release of funds to  
the tune of **Rs.4023.70 lakhs (Rupees forty crore twenty three lac and  
seventy thousand) only** out of the Capex Budget 2016-17 in favour of Director  
Employment J&K and their further placement at the disposal of Director  
Entrepreneurship Development Institute (EDI J&K, under the scheme "Seed Capital Fund  
Scheme (SCF)-Self Employment (State sector) for its implementation.

The authorization is subject to the following conditions:

1. Director Employment shall vouchsafe the availability of funds under Capex  
Budget 2016-17
2. The funds shall be utilized for approved schemes/projects after fulfillment of all  
the codal formalities
3. No diversion/re-appropriation of funds shall be allowed in any case.
4. Utilization Certificates /Red Account shall be furnished to the concerned quarters  
well in time.
5. That Entrepreneurship Development Institute (EDI) shall obtain a final decision on  
continuance or otherwise of each and every scheme in vogue as per budget  
announcement.
6. The expenditure shall be debitable to the following object Heads:
  - i. Demand No; 25
  - ii. Major Head 4250- Capital outlay on other Social Services
  - iii. Sub Major Head 00
  - iv. Minor Head 203- Employment
  - v. Group Head 0011 General
  - vi. Sub Head 1904-Employment
