Sanction is hereby accorded to the advance drawal to the tune of **Rs.25.00 lakhs (Rupees twenty five lakhs only)** in favour of Labour Commissioner, J&K for its further placement at disposal of Assistant Labour Commissioner, Samba for construction of Labour Sarai Samba during current financial year 2018-19.

The authorization is subject to the following conditions:

1. That the Labour Commissioner, J&K shall vouchsafe the availability of funds under Capex Budget 2018-19.
2. That the funds shall be utilized for approved schemes/projects after fulfillment of all the codal formalities and Utilization Certificates are sent to all the concerned quarters including Finance Department well within stipulated time and the amount is utilized for the activities specifically provisioned for.
3. Utilization Certificates /Red Account shall be furnished to the concerned quarters well in time.
4. Funds should not be utilized for Revenue or Revenue like items.
5. The funds should not be parked un-necessarily.
6. The funds so released shall not be available for re-appropriation/diversion at any level
7. The expenditure shall be debitable to the following object Heads:
 - i. Demand No: 25
 - ii. Major Head 4250- Capital outlay on other Social Services
 - iii. Sub-Major Head 00
 - iv. Minor Head 201 Labour
 - v. Group Head 0011-General
 - vi. Sub Head 1903-Labour
