Whereas, vide Office order No. 125-LC of 2018 dated 01.06.2018 issued by Labour Commissioner, J&K Shri Mohammad Sharief, (I/c Supervisor) was attached to the office of Dy. Labour Commissioner, Jammu:

Whereas, Assistant Labour Commissioner, Poonch was appointed as Enquiry Officer to conduct an enquiry into the matter and submit his report within 21 days to the office of Labour commissioner:

Whereas, Assistant Labour commissioner, Poonch submitted his enquiry report vide letter no. ALC/P/2018/131-32 dated 24.07.2018 in the office of Labour Commissioner and reported that the allegations levelled against Mr. Mohd Sharief I/c Supervisor who was working in the office of Assistant Labour Commissioner, Rajouri and then attached in the office of the Deputy Labour commissioner, Jammu are baseless;

Whereas, vide Office order No. 151-LC of 2018 dated 09.08.2018 issued by Labour Commissioner, J&K, the official was transferred to the office of Assistant Labour Commissioner, Poonch:

Whereas, in the meantime the official approached to the Hon'ble High court at Jammu and the Hon'ble court stayed the impugned order No. 151-LC of 2018 on 09.08.2018. The Operating part of the said order reproduced as under:-

“Meanwhile, subject to objections and till next date before the Bench, the order impugned dated 09.08.2018 qua the petitioner shall remain stayed”.

Whereas, by virtue of the above mentioned court order, the official was automatically deemed to have been attached in the office of Dy. Labour Commissioner, Jammu i.e. his previous place of posting.

Now, in view of the enquiry report submitted by the Assistant Labour commissioner, Poonch, the Official namely Shri Mohammad Sharief, (I/c Supervisor) is reinstated with immediate effect with release of salary withheld from August, 2018 and is allowed to work in the office of Assistant Labour Commissioner Rajouri in view of the Court directions and a warning is issued to him to remain careful in future.
