Sanction is hereby accorded to the temporary appointment of Mst. Rafiq Bano W/o Late Mohammad Ashraf Mir (Ex-Junior Assistant) R/o Mirakabad Shalimar Srinagar, as Orderly (class-IV), in the pay Level SL-1 (14800-47100) in the Labour Department, State Cadre, in relaxation of prescribed qualification in terms of Rule-7 under SRO-43 of 1994.

The appointee shall report to the Labour Commissioner, J&K, Srinagar within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following certificates/documents in original as required under rules:-

- i) Academic Qualification Certificate.
- ii) Age and Health Certificate.
- iii) Permanent Resident Certificate.
- iv) All other relevant documents as required under SRO-43/1994.
- v) No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.

The appointee shall be initially on probation for a period of two years; and if, on verification, the certificates produced by the appointee proved to be fake or forged, the appointment shall stand as cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about the verification of her character and antecedents is received from the Inspector General of Police, CID to whom a reference shall be made by the Labour Commissioner, J&K, Srinagar.
