Sanction is hereby accorded for revalidation/release of funds amounting to Rs. 53,82,464.00 (Rupees fifty three lakh eighty two thousand four hundred sixty four only) under CSS-National Career Service Project (Mission mode project) for interlinking of Employment Exchanges in favour of Director Employment, J&K for their utilization during the current financial year 2018-19 through BEAMS as per the break given below:

- i. Rs. 2,02,678.00 For IT infrastructure.
- ii. Rs 14,90,177.00 for refurbishing.
- iii. Rs 36,89,609.00 for job fair.

The revalidation is subject to the following conditions:

1. The funds shall be utilized for execution of the scheme strictly as per originally approved components and prescribed guidelines issued by Ministry of Labour and Employment , Government of India vide No: DGE&T-M-27014/1/2016-NCS(Coord) dated 28.06.2016.
2. The department shall send a status report about the scheme, in terms of physical and financial progress made during the current year and up to date cumulative expenditure and physical achievement.
3. The department shall send utilization certificates of the funds, as early as possible and definitely before 31.03.2019 to GOI with a copy to the Finance Department.
4. Director Employment, J&K shall vouchsafe the utilization of funds released as per the codal procedure/Government of India's guidelines.
