Sanction is hereby accorded to the advance drawal and release of funds to the tune of **Rs.300.00 lakhs (Rupees three crore only)** as state share out of the Capex Budget 2017-18 in favour of Director Employment and their further placement at the disposal of Director Entrepreneurship Development Institute (EDI) J&K, under the scheme "National Minority Development Finance Corporation (NMDFC)–Self Employment (State sector) for its implementation during current financial year 2017-18.

The authorization is subject to the following conditions:

1. That the Director Employment shall vouchsafe the availability of funds under Capex Budget 2017-18.
2. That the funds shall be utilized for approved schemes/projects after fulfillment of all the codal formalities and Utilization Certificates are sent to all the concerned quarters including Finance Department well within stipulated time and the amount is utilized for the activities specifically provisioned for
3. That the Entrepreneurship Development Institute (EDI) shall submit a report regarding funds mobilized by it from lending Institutions, Industries and Commerce Department and Labour and Employment during the last so many years and status of their recovery from loanees and refund to the State Government.
4. The expenditure shall be debitable to the following object Heads:
 - i. Demand No: 25
 - ii. Major Head 4250- Capital outlay on other Social Services
 - iii. Sub-Major Head 00
 - iv. Minor Head 203- Employment
 - v. Group Head 0011-General
 - vi. Sub Head 1904-Employment


