No hard/manual copy (s) shall be entertained/allowed, in any form, whatsoever.

It is further ordered that occupiers/unit holders/employers shall maintain all the records like registers, returns, etc, in the **digital/electronic form**, under all Labour Acts applicable in the State of J&K.

The Labour Commissioner, J&K shall give vide publicity to this order through electronic and print media, awareness camps, etc.


