**Sub: Monitoring of Self Employment Schemes for unemployed Youth & welfare schemes for Labourers in J&K.**

**Government Order No: 39-L&E of 2020**

**Dated: 26.06.2020**

There are important schemes of Labour & Employment Department for the welfare of the general public being implemented across the Union Territory of J&K through JKEDI/ Women Development Corporation with the sole intension to create a good impact on the targeted population.

Whereas, Child Labour and bonded labour has to be checked as the menace in rural as well as urban areas. Children of many poor families are not able to attain education and are engaged in forced working/domestic aids in well to do households and establishments.

Whereas, the main schemes launched by the Government for un-employed youth are Seed Capital Fund Scheme (SCFS), Youth Start-up Loan Scheme (YSLs), National Minority Development Finance Corporation (NMDFC) and Women Entrepreneurship Programme (WEP).

The government has launched scholarship scheme for worker's children through J&K Building and Other Construction Workers Welfare Board (BOCWWB) which facilitates the poor for furthering education of their children.

In order to ensure effective implementation of the above schemes meant for Labour Welfare and unemployed youth at grass root level, the Chairpersons of Block Development Councils and Chairpersons of Municipal Corporation/Committees respectively for Rural and Urban areas are hereby empowered to monitor the schemes across the J&K, UT within their jurisdiction. The concerned Assistant Labour Commissioners/District Nodal Officer of JKEDI/representative of Women Development Corporation of the districts shall ensure to impart proper awareness to the general public through PRIs and extend support wherever necessary.
