Sanction is hereby accorded to the advance drawal of funds to the tune of **Rs. 250.00 lakhs (Rupees Two Crore Fifty lakhs only)** out of funds available with the Department under classification: 4250-00-203-0011-1904 under Capex Budget 2023-24 in favour of Director Employment, J&K for its further placement at the disposal of MD, Women's Development Corporation under the scheme "Women Entrepreneurship Programme" –Self Employment (State sector) for its utilization during the current financial year 2023-24.

The release of funds is subject to the following conditions that:

1. The payment is made in DBT mode only.
2. That funds so released shall not be diverted at any cost.
3. The beneficiary details with amount disbursed uploaded on the DBT portal.
4. The whole loan amount of previous years along with interest is recovered in full from the beneficiaries of the scheme.
5. The expenditure shall be booked on admissible items only as approved in the scheme by the competent authority after observing all required codal formalities as per GFR.
6. The scheme is not implemented either by Social Welfare Department or Directorate of Mission Youth J&K or any other Department. The beneficiary in no case shall have availed loan in other scheme funded by Government.
7. Red account of advance drawl shall be furnished to the concerned Department including A.G well in time.
8. That the Department shall also confirm that the beneficiaries of the scheme have not availed funding from UT Govt in the last 3 years and that she does not have any pending non-standard dues to any UT Dept (SWD, Mission Youth, Labour & Employment, ROD, etc) or public sector banks
