**S.O.**\_\_\_\_\_ In exercise of the powers conferred by section 35 of the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Act, 1979 (30 of 1979), the Government of Jammu and Kashmir hereby intends to make following amendments in the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Jammu and Kashmir Rules, 1984; namely:-

1. In rule 4, after sub-rule (1), the following sub-rule shall be inserted; namely:


"(1a) The Registering Authority shall grant the registration within a period of 45 days after receiving the application, if satisfied about the eligibility of the applicant. In case of failure to issue the registration within stipulated time, it shall be deemed that the approval has been granted."

2. In rule 9, after sub-rule (1), the following sub-rule shall be inserted; namely:

"(1a) The Licensing Authority shall grant the license within a period of 45 days after receiving the application, if satisfied about the eligibility of the applicant. In case of failure to issue the registration within stipulated time, it shall be deemed that the approval has been granted."

Now, in pursuance of section 35 of the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Act, 1979 (30 of 1979), the aforesaid amendments are hereby published for information of general public for inviting objections, suggestion.

Any person who desires to object the afore-said amendments may submit his/her objections/suggestion for consideration in writing to the Secretary to Government,



Labour and Employment Department, Civil Secretariat within a period of 15 days from the date of issuance of this notification.

Any objection/suggestion received after the expiry of the said period shall not be entertained.


